POLICE BLOTTER

Monday, December 27, 2010

1515 An officer responded to the lobby of KPD for a subject wanted on a KMC arrest warrant for Theft and Breaking and Entering. Upon arrival, the warrants and ID of the suspect were confirmed. Nicholas S Able, wm, 30; was arrested and taken back to KPD Jail for booking. 10-51562

1720 An officer conducted a traffic stop in the 4000 blk of Wilmington Pike. During the course of the stop, he requested the assistance of K-9 Bandit to do a free air sniff. Bandit alerted on the vehicle and after a search by the officers, bags of suspected marijuana as well as drug paraphernalia were discovered in the vehicle. Arrested was Cody A. Tangeman W/M/19 for possession of Drug Paraphernalia. Tangeman was also cited for Possession of Drugs. 10-61006
