POLICE BLOTTER

Monday March 04, 2008

1600 Crews were sent to Fox Hunt Apt, 2095 Valley Greene Dr, on a trespassing complaint. Employees of the complex reported seeing a subject on the property that had been previously trespassed. **Lori A. Payne (W/F 24)** was located and arrested for Criminal trespassing (08-11554). Payne was transported to KPD jail for processing.

Thursday March 06, 2008
