No other compensation or benefits is either implied or due, except as expressly provided for in this Agreement. The CITY shall make deductions from the SPECIAL EMPLOYEE's pay as required by law, including but not limited to, federal, state and local tax withholdings and any contributions to FICA/Medicare or the Ohio Public Employees Retirement System.

Section 4 - Employee-at-Will, Notice of Termination. The SPECIAL EMPLOYEE and the CITY have an employee-employer relationship which is conditioned upon an "employment-at-will" basis. Specifically, the SPECIAL EMPLOYEE has the right to terminate this Agreement at any time, subject to fourteen (14) days' written notice, and the CITY has the same right, subject to fourteen (14) days' written notice, unless specified otherwise herein. The SPECIAL EMPLOYEE's status shall be temporary, subject to the terms of this Agreement and is in the unclassified Civil Service pursuant to the City Charter.

Section 5 - Need for Personnel Action. The obligations of the parties are subject to and contingent upon a City of Kettering Personnel Action form being signed by or through the City Manager, so as to authorize hiring of the SPECIAL EMPLOYEE.

Section 6 - Termination Without 14 Days' Notice. ## SPECIAL EMPLOYEE AGREEMENT

This special employee agreement (this "Agreement") is entered into by and between the City of Kettering, Ohio, hereinafter called the "CITY" or "EMPLOYER," and Karen D. Durham, hereinafter called the "SPECIAL EMPLOYEE" or the "EMPLOYEE."

WHEREAS, the CITY desires to engage the EMPLOYEE commencing December 14, 2015 under the provisions of this Agreement and the EMPLOYEE desires to be so engaged;

NOW, THEREFORE, the parties mutually agree to the following:

Section 1 - Purposes of Employment. The CITY hereby employs the personal services of the SPECIAL EMPLOYEE for the purpose(s) of: (i.) performing the duties of the General Manager of the Fraze Pavilion, and (ii.) such other duties and services as may be assigned by the Kettering City Manager, the Director of the City of Kettering Department of Parks, Recreation and Cultural Arts ("PRCA"), or their respective designees. All such duties and services shall be subject to the provisions of this Agreement.

Section 2 - Rules; Supervision. At all times the SPECIAL EMPLOYEE shall perform the required services and duties in a professional manner and in conformance with all applicable rules, regulations, policies and procedures of the CITY, whether existing now or subsequently adopted while this Agreement is in effect. The SPECIAL EMPLOYEE further agrees to perform the required services and duties under the supervision and direction of the Director of PRCA or any designee appointed by the Director of PRCA for such purposes, or the City of Kettering City Manager or the designee of the City Manager. At all times while this Agreement is in effect, SPECIAL EMPLOYEE shall be subject to the administrative policies of the City of Kettering regarding employees. The services and duties to be provided by SPECIAL EMPLOYEE under this Agreement shall require SPECIAL EMPLOYEE to provide such services and duties on such workdays and during such hours as necessary to satisfactorily complete the services and duties and/or as may be requested by the Director of PRCA or any designee appointed by the Director of PRCA for such purposes, or the City of Kettering City Manager or the designee of the City Manager.

Section 3 - Compensation. The CITY agrees to compensate the SPECIAL EMPLOYEE, for services and duties provided, in the following manner:

- (i.) Commencing December 14, 2015 and continuing thereafter while this Agreement is in effect, the CITY shall pay EMPLOYEE at the maximum hourly rate established in the City's Personnel Ordinance in effect as of December 14, 2015 or any subsequent amendments thereto for Pay Grade 718. EMPLOYEE's compensation shall be paid to EMPLOYEE in periodic, equal payments (approximately every two weeks) the same as periodic payments are made to full time CITY employees in the 700 pay grade series.
- (ii.) Commencing December 14, 2015, and continuing thereafter while this Agreement is in effect, so long as participation is desired by the EMPLOYEE the CITY shall deem

EMPLOYEE eligible to participate in the Ohio Public Employee Retirement System ("OPERS") and shall withhold for EMPLOYEE's contribution to OPERS from compensation from the CITY. So long as EMPLOYEE is eligible for and does participate in contributing to OPERS, then the CITY shall make payment of the CITY's commensurate contribution to OPERS.

- (iii.) Commencing December 14, 2015 and continuing thereafter while this Agreement is in effect, EMPLOYEE shall not be eligible for and shall not receive from the CITY any form of automobile allowance. However, EMPLOYEE shall have made available to EMPLOYEE an automobile from the City-owned fleet that may be used by EMPLOYEE for business use only. EMPLOYEE shall not use any City owned vehicle for commuting purposes.
- (vi.) During the term of this Agreement, EMPLOYEE will be eligible for a cellular device stipend the same as regular employees of the CITY.

The computer shall be suitable to conduct CITY business and EMPLOYEE shall use such computer only for CITY business.
- (vi.) EMPLOYEE's eligibility for health insurance coverage will be determined in compliance with the Patient Protection and Affordability Care Act (PPACA) and its applicable regulations as interpreted and applied by the CITY for other similarly situated employees. Such eligibility shall be evaluated on an annual basis at the conclusion of the CITY's PPACA eligibility measurement period. In the event the EMPLOYEE is eligible for health insurance coverage, such coverage shall be the same as offered to all non-union CITY employees and the EMPLOYEE must enroll or waive coverage by any and all applicable enrollment deadlines.
- (vii.) Notwithstanding any other provisions of this Agreement, EMPLOYEE acknowledges and agrees this Agreement does not entitle EMPLOYEE to be eligible for and therefore under this Agreement EMPLOYEE shall not receive from the CITY any of the following benefits: dental insurance, life insurance, sick leave, vacation leave, personal leave, funeral leave or any other form of leave.
- (viii.) Except as expressly provided for in this Agreement, no other compensation anno other benefits are either implied nor due EMPLOYEE. The CITY shall make deductions from the SPECIAL EMPLOYEE's pay as required by law, including but not limited to, federal, state and local tax withholdings and any contributions to FICA or OPERS. Notwithstanding any other provision of this Agreement, EMPLOYEE hereby expressly agrees that this Agreement and the relationship between EMPLOYEE and the CITY permits the CITY to withhold and retain local (Kettering) income tax from the CITY's compensation to EMPLOYEE under this Agreement and EMPLOYEE hereby waives any objection to such withholding.

Section 4 - Minimum Time. EMPLOYEE shall work the number of hours and provide the necessary professional resources to fully accomplish and complete the duties and services expected of EMPLOYEE under Section 1 of and pursuant to this Agreement.

- (i.) At minimum, EMPLOYEE shall perform at the Frazee Pavilion facility the duties and services under Section 1 of this Agreement, for the follows periods of time:
- A minimum of five (5) business days during the month of March 2016 as mutually agreed upon in writing by EMPLOYEE and the Director of PRCA; and
  - Other full-time days, as mutually agreed to by the EMPLOYEE and the Director of PRCA, during the months of January 2016 through March 2016, for the purpose of discussing departmental issues and/or operational needs; and
  - Regular, full-time (40 hours per week) for the period April 25, 2016 through and including September 6, 2016; and
  - Five (5) full business days for the month of October 2016, which may include hour-for-hour attendance any day of the week at the IEBA conference in Nashville, TN; and
  - During all "next-season" staff evaluations, interviews and hiring meetings conducted during the months of November and December 2016 negotiated with the PRCA Director.
  - Employee will need to be present and on duty for all ticketed, festivals and free events throughout the 2016 season, unless prior arrangements are made in writing with the PRCA Director. Employee is requested to assign a "manager on duty" for any shows that she will not be present. Arts on the Common and Holiday At Home are excluded.
- (ii.) For purposes of item (i.), immediately above, a full business day shall mean any day Monday through and including Friday (excluding any legal CITY holiday) for which at least 8 hours per day is worked on CITY business.

Section 5 - . Employee-at-Will, Notice of Termination. The SPECIAL EMPLOYEE and the CITY have an employee-employer relationship which is conditioned upon an "employment-at-will" basis. Specifically, the SPECIAL EMPLOYEE has the right to terminate this Agreement at any time, subject to thirty (30) days' written notice, and the CITY has the same right, subject to thirty (30) days' written notice, unless specified otherwise herein. The SPECIAL EMPLOYEE's status shall be temporary, subject to the terms of this Agreement and is in the unclassified Civil Service pursuant to the City Charter. In the event the City determines the EMPLOYEE has or is engaging in criminal activities

and/or fraud, then in such event the CITY shall have the option, in its sole discretion, to immediately terminate this Agreement without any advanced notice.

Section 6 - No Subcontracting/Assignment. Without the expressed written permission of the Kettering City Manager, the CITY Finance Director, the Director of PRCA, and the CITY Law Director, the SPECIAL EMPLOYEE is prohibited from, in any fashion or manner, assigning to another party, the EMPLOYEE's responsibilities and obligations to perform the services and duties required of the SPECIAL EMPLOYEE under this Agreement.

Section 7 - Records and Forms. The SPECIAL EMPLOYEE shall keep and/or submit all records and forms determined reasonably necessary by the CITY for purposes of this Agreement. Failure to meet this requirement within established deadlines set by the CITY may result in immediate termination of this Agreement without advanced notice to EMPLOYEE.

Section 8 - Compensation on Termination. Should this Agreement be terminated prior to its expiration date, the CITY shall pay to the SPECIAL EMPLOYEE only the sum then due for the work performed up through the date of termination.

Section 9 - Waiver of Claims. EMPLOYEE shall and hereby does expressly waive any and all claims EMPLOYEE may have against the CITY on the basis of or related to, whether wholly or partly, any failure or refusal of the CITY at any time subsequent to January 18, 2009, to hire, employ or engage the EMPLOYEE in any employment position or create an employee-employer relationship between the parties..

Section 10 - Defense. EMPLOYEE shall be entitled to and shall receive from the CITY at EMPLOYEE's request, legal defense for any claims brought by a third party against EMPLOYEE as a result of EMPLOYEE carrying out the duties imposed on EMPLOYEE by this Agreement and so long as the claim does not arise from, whether directly or indirectly, any behavior, action or inaction of EMPLOYEE that is outside the scope of EMPLOYEE's duties under this Agreement.

Section 11 - Entire Agreement. This written document represents the entire and integrated agreement between the CITY and the EMPLOYEE and supersedes all prior negotiations, representations and agreements, whether oral or written. This Agreement may be amended only by a written document signed by both the EMPLOYEE and the Kettering City Manager.

Section 12 - Conflicts of Interest. The EMPLOYEE shall not accept assignments from or perform services for other parties which conflict in any way with the duties and services to be provided by EMPLOYEE for the CITY under Section 1 of this Agreement, or which, alone or when combined with other factors, prevent completion of EMPLOYEE's duties and services for the CITY.


Section 13 - Applicable Law. The SPECIAL EMPLOYEE will obtain approval for others to assist or substitute for him or her from designated CITY staff who have authority to make such decisions/assignments. Any attempted assignment or subcontracting of this Agreement without the written consent of the City shall be void.

Section 8 - Records and Forms. The SPECIAL EMPLOYEE shall keep and/or submit all records and forms determined necessary for the CITY for purposes of employment and program operations. Failure to meet this requirement within established deadlines set by the CITY may result in immediate termination of this Agreement, without necessity of the advance notice described in Section 4. The CITY shall not be arbitrary in setting of said deadlines.

Section 9 - Compensation on Termination. Should this Agreement be terminated prior to its expiration date, the CITY shall pay to the SPECIAL EMPLOYEE only the sum then due for the work performed.

Section 10 - Severability. If any term, provision, covenant, or condition of this Agreement is held by a court of competent jurisdiction to be invalid, void or unenforceable, the rest of this Agreement shall remain in full force and effect at the option of the City.

IN WITNESS WHEREOF, each party has signed this Agreement on the day and year following his or her signature. This Agreement shall be in force commencing: 04/04/2016 and terminating: 12/11/2016 (not to exceed a 12-month period).


